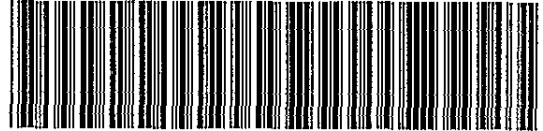



ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a not for profit corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation.

**ARTICLE I**

The name of the corporation shall be: BAKER COUNTY TOUCHDOWN CLUB, INC.

**ARTICLE II**

The principal place of business of the corporation shall be Memorial Stadium, Macclenny, Baker County, Florida 32063. The mailing address of the corporation shall be P.O. Box 875, Macclenny, Florida 32063.

**ARTICLE III**

The purpose for which the corporation is organized is to operate exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

To conduct program and activities; raise funds; request and receive grants, gifts and bequest of money; to promote academics and sports within Baker County; acquire, receive, hold, invest and administer, in its own name, securities, funds, objects of value, or other property, real or personal; and make expenditure to or for the direct or indirect benefit of the Baker County High School Athletic Program, and the Baker County Youth Football Program; to work with the administration and coaches and all interested groups in building better athletic programs through financial and moral support; to promote good fellowship, foster good sportsmanship, and to encourage a proper school and community spirit among the citizens of Baker County.

To receive and hold by gift, bequest or purchase any real or personal property and to manage, invest and reinvest the same and to use and dispose of

the same for educational and charitable purposes, all for the advancement of Athletics within Baker County, as well as to promote academics, sportsmanship, community spirit, and athletics; to hold, either absolutely or in trust for any of said purposes, funds and property of all kinds subject only to any limitations or conditions imposed by law or the instrument under which said property is received; to sell, lease, convey or otherwise dispose of any such property and to reinvest the same or any proceeds thereof and to deal with and expand the principal and income for any of said purposes; to act as trustee; and, in general, to exercise any, all, and every power, including trust powers, which as corporation not for profit organized under the laws of the State of Florida for the foregoing purposes can be authorized to exercise.

#### ARTICLE IV

The manner in which the directors are elected or appointed shall be in the manner provided in the by-laws.


