

ARTICLES OF INCORPORATION In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I:

The name of the corporation shall be:

POUNDPUPPIES & POUNDKITTIES, INC.

ARTICLE II: PRINCIPAL OFFICE
