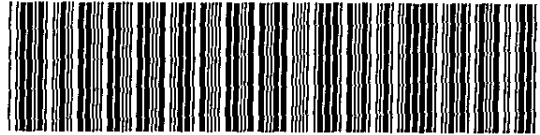

ARTICLE III: THE PURPOSE OF THE CORPORATION


