ARTICLES OF INCORPORATION OF MIAMI LAKES CITIZEN ACTION COMMITTEE, INC.

The undersigned incorporation, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be: MIAMI LAKES CITIZEN ACTION COMMITTEE, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and the mailing address of this corporation shall be 800 Brickell Avenue, Penthouse 2, Miami, Florida 33131.
