

#### ARTICLES OF AMENDMENT

## To ARTICLES OF INCORPORATION Of

# DEPARTMENT OF FLORIDA, VETERANS OF FOREIGN WARS, FOUNDATION, INC

Article I - Name of corporation
The name of the corporation shall be: DEPARTMENT OF FLORIDA, VETERANS OF FOREIGN
WARS, FOUNDATION, INC.
Articles amended: Article IV, after "Section 501©(3) of the Internal Revenue Code or
corresponding sections of any future Federal tax code," DELETE: "including those purposes which
may be set forth in the by-laws adopted by the corporation." And ADD: "The corporation is also
organized for the making of distributions to organizations that qualify as exempt organizations under
Section 501©(3) of the Internal Revenue Code and such other exempt organizations to which
distributions can now or hereafter be made without adverse tax consequences.

<u>Purposes and Objectives:</u> Without limiting the generality of the foregoing, specific purposes and objectives include:

- (1) To assist disabled and needy veterans and their families.
- (2) To promote programs that focus public attention upon and educate the public concerning the sacrifices made by America's veterans, the unique and special needs of veterans and their families resulting from their service, the needs of active duty and reserve military personnel and their families and other issues relating to veterans.
- (3) To promote programs that advise and assist veterans with respect to employment, training and education.
- (4) To foster patriotism and educate the public concerning American ideals and institutions, the history of the United States and the contributions made by America's veterans to secure America's freedom and prosperity.
- (5) To assist in funding and promoting programs sponsored by the Veterans of Foreign Wars of the United States, its affiliates and other nonprofit groups to assist veterans and their families, including veterans service and employment programs, programs to encourage and enhance research and education concerning the special needs of veterans, programs to study the impact of technology and public policy on veterans, programs to assist homeless and disadvantaged veterans and other programs related to veterans' issues and national defense.
- (6) To promote the programs that foster patriotism, education, community service and youth activities, including those programs sponsored and conducted by the Veterans of Foreign Wars of the United States, its affiliates and other nonprofit groups.

ARTICLE V - DELETE in its entirety. ARTICLE V - AMENDED TO READ: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation or organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of Section 501©(3) purposes.

ARTICLE VI – DELETE in its entirety. ARTICLE VI – AMENDED TO READ: No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

ARTICLE VII – DELETE IN ITS ENTIRETY – ARTICLE VII – AMENDED TO READ: Notwithstanding any other provision of these articles, the corporation shall not carry on any activities not permitted to be carried on (a) by a corporation or organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code) or(b) by a corporation or organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code (or corresponding section of any future Federal tax code).

ADD: ARTICLE VIII - Upon the dissolution of the corporation or organization, assets shall be distributed for one or more exempt purposes with the meaning of Section 501©(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose.

**ADD**: ARTICLE IX - Membership. The corporation shall have no voting members. Solely its Board of Directors shall manage its affairs, which shall be self-perpetuated in accordance with the terms of the by-laws from time to time adopted by the corporation.
