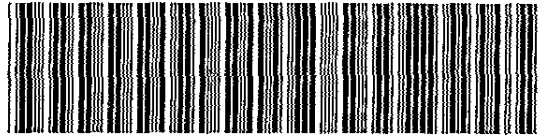



**ARTICLES OF INCORPORATION
OF
CITY SAVERS, INC.**

The undersigned incorporator, for the purpose of forming a corporation under Chapter 617 of the Florida Statutes (Not for Profit), hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the Corporation is: City Savers, Inc.

ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office of the Corporation and its mailing address is 12104 Shady Forest Drive, Riverview, Florida 33569. The location of the principal office and the mailing address shall be subject to change as may be provided in the Bylaws of the Corporation.

ARTICLE III: DURATION

The Corporation shall exist perpetually unless sooner dissolved according to law.

ARTICLE IV: PURPOSES AND POWERS

The purpose for which the Corporation is organized is:

1. Attached hereto as Schedule "A".
2. To do everything necessary, proper, advisable, or convenient for the accomplishment of the purposes, or the attainment of any of the objects, or the furtherance of any of the powers herein set forth, either alone or in association with others incidental or pertaining to, or going out of, or connected with its business or powers, provided the same shall not be inconsistent with the laws of the state of Florida.
3. The clauses contained in this statement of the general nature of the business or businesses to be transacted shall be construed as both purposes and powers of this Corporation, and statements contained in each clause shall, except as otherwise expressed, be in no ways limited or restricted by reference to or inference from the terms of any other clause. They shall be regarded as independent purposes and powers.

Nothing herein contained shall be deemed or construed as authorizing or permitting, or purporting to authorize or permit the Corporation to carry on any business, exercise any power, or do any act which the Corporation may not, under the laws of the state of Florida, lawfully carry on, exercise, or do.

ARTICLE V: ADDRESS OF REGISTERED AGENT

The name and address of the initial registered agent of the Corporation is Jon Buckles, 12104 Shady Forest Drive, Riverview, Florida 33569.

ARTICLE VI: INITIAL BOARD OF DIRECTORS

The number of directors constituting the Corporation's Board of Directors shall not be less than three (3), and the exact number of Directors shall be fixed from time to time in the manner provided in the Bylaws of the Corporation. 
