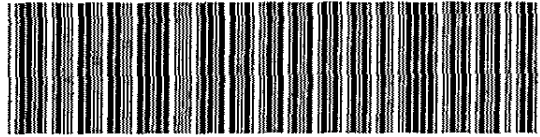

Amended Article III: Purpose

Sweet Impressions Learning Center, Inc is organized exclusively for educational purposes as qualified as an exempt organization under section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

Added Article VII: Net Earnings Clause

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III thereof.

Added Article VIII: Dissolution Clause

Upon the dissolution of the corporation, the board shall, after paying or making provisions for the payment of all the liabilities of the corporation, dispose of all assets of the corporation exclusively for purposes of the corporation in such manner or to such organization(s) organized and operated exclusively for charitable, educational, religious or scientific purposes as shall at the time qualify as an exempt organization under the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Any such assets not so disposed of shall be disposed by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization(s), as said court shall determine, which are organized and operated exclusively for such purposes.
