Articles of Incorporation
Of

The undersigned Incorporator for the purpose of forming a corporation under the Florida Non-Profit Corporation Act, hereby adopts the following Articles of Incorporation:

Article I

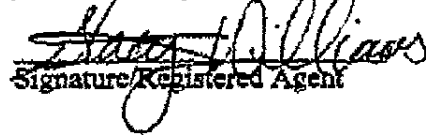
