

ARTICLES OF INCORPORATION OF IGLESIA EN MANOS DEL ALFARERO, INC. A FLORIDA NON-PROFIT CORPORATION

- Article 1. Name. The name of the corporation is Iglesia En Manos Del Alfarero, Inc.
- Article 2. Duration. The duration of the corporation is perpetual unless dissolved according the law.

Article 3. Purpose. The purpose of the corporation is as follows:

This corporation is a non-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation is to

- A. Act as a regilious organization and a church:
- B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.
- C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

Article 4, Members. The Corporation shall have voting members, who shall be elected (and may be removed) by the voting members, and who shall have all the rights and privileges of members of the corporation. The By Laws may provide for nonvoting members of one or more classes, who shall be admitted in such a manner and who shall have such rights and privileges as are set forth in the By Laws, but who shall not have the right to vote. Article 9, Incorporator. The incorporator of the Corporation shall be Hilda Ojeda, 2417 Hybrid Dr., Kissimmee, Florida 34758

Article 10, Nonstock Basis. The corporation is organized (and shall be operated) on a nonstock basis within the meaning of the Florida Not For Profit Corporation Act, and shall not have the power to issue shares of any type or class of stock, but may issue membership certificates if so provided in the Bylaws.

Article 11. Dissolution. In the event of dissolution, the residual assets of the corporation shall be turned over to one or more organizations which themselves are exempt as organizations described in Section 501 (C) (3) and 170 (C) (2) of the Internal Revenue Code of 1954 or corresponding section of any prior of future law, or to the Federal, State or Local government for exclusive purpose.
