I the undersigned, being an adult, and being of sound mind and enjoying all my civil rights, with the purpose of establishing a non-profit corporation, my intent is to establish and construct this corporation conforming to instructions of the FLORIDA DEPARTMENT OF STATE, Division of Corporations

ARTICLE I NAME

The name of the Incorporation shall be: A GRATEFUL WOMAN OF GOD, INC.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 5457 10th Avenue, Fort Myers, Florida 33907.

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

- a. To work in the rural communities, and in developing countries to obtain their spiritual growth according to the Holy Scriptures.
- b. To cooperate with penal institutions, hospitals, and rehabilitation centers when called upon to do so.
- c. To hold crusades whose purpose will be to bless people.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

The President:

As president I shall preside over all the reunions. As for the official directors, they will be recognized only if they are an active member of a protestant evangelical church that professes biblical repentance of their sins and that have accepted and confessed Jesus Christ as their only Savior, being baptized in water and living a Holy Life according to the Holy Scriptures, that they believe in the Trinity, ONE

The amount of time that the officials will serve: Voluntary Retirement: Any official that voluntarily wants to retire from being an Official Board Member, may do so, in writing, stating the reason why they no longer wish to serve.

Expulsion or Suspension: May be found necessary when an official is in conflict with the principles or rules of the constitution of A GRATEFUL WOMAN OF GOD MINSTRIES, INC. Expulsion may be necessary if there is a misappropriation of funds, and if there are moral or religious violations.

The manner in which they will be elected are as follows: having filled all the requirements above, the person must then be accepted by all the directors of the committee which includes myself as president.

In the event that the ministry were to be dissolved, all properties which are to belong to the organization and not to the officials, are to be donated to a non-profit born-again Christian Organization.




