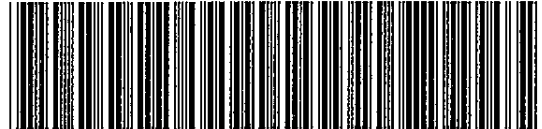

To be amended to Article III Purposes:

- (a) The Sounds of Joy, Inc. is organized exclusively for charitable, and religious purposes, including traveling in a bus and doing concerts for churches and church related functions. This is done on weekends when various churches invite us to do so. For such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.**
- (b) No part of the net earnings of The Sounds of Joy, Inc. shall inure to the benefit of, or to be distributable to its members, trustees, officers, or other private persons, except that The Sounds of Joy, Inc. shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of The Sounds of Joy, Inc. shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and The Sounds of Joy, Inc. shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on the behalf of any candidate for public office. Notwithstanding any other provision of this document, The Sounds of Joy, Inc. shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.**
- (c) Upon the dissolution of The Sounds of Joy, Inc., assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of The Sounds of Joy, Inc. is then located, exclusively for such purposes or to such organization or organizations, as said Court shall**

determine, which are organized and operated exclusively for such purposes.

The Sounds of Joy, Inc. is a non-profit organization. We are a religious singing group. We sing and play gospel music at churches and church affiliated activities. None of the members or anyone outside the group are paid, from the donations we receive. We(The Sounds of Joy, Inc.) do not support or donate anything to political or any other organizations.

For any reason The Sounds of Joy, Inc. dissolves, we will willingly donate any funds and/or equipment we hold will be donated to a church or other non-profit gospel group.

____ACTIVITIES____

Singing gospel music at churches, church activities and revivals to spread the word of the LORD. Average time spent doing this is from one to three hours per event. The group sings almost every weekend of the year. One hundred percent of the donations (love offerings), are used to travel from activity to activity. We use the money to buy diesel, oil, and other mechanical needs for the bus. All the group members volunteer their time to sing. Everyone has full time jobs.
