Pursuant to the provisions of section 617.1006, Florida Statutes, this *Florida Not For Profit Corporation* adopts the following amendment(s) to its Articles of Incorporation:

Adding the following additional Articles:

10. **Dissolution.** This corporation may be dissolved in accordance with the laws of the State of Florida. Upon this dissolution of this corporation, any surplus property remaining after the payment of its debts shall be disposed of by transfer to one or more corporations, associations, institutions, trusts, community chests or foundations organized and operated exclusively for one or more of the purposes of this corporation, and described in section 501 (c)3 of the Internal Revenue Code of 1954, or its progeny, in such proportions as the member of the corporation shall determine. Notwithstanding any provision herein to the contrary, nothing herein shall be construed to affect the disposition of property and assets held by this corporation upon trust of other conditions, or subject to any executory or special limitation, and such property, upon dissolution of this corporation, shall be transferred in accordance with the Bylaws of the corporation.

This amendment was adopted on this 30 day of October, 2011

The effective date of this filing shall be November 1, 2011.
