

## ARTICLE I - NAME

Name: The name of the corporation shall be: Research Center for Bayesian Applications, Inc.

# ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this not for profit research corporation shall be: 8799 Bardmoor Boulevard, Suite 201, Largo, Florida 33777

# ARTICLE III – PURPOSES

Bayesian analysis implies the exploitation of a suitable prior information about the parameters involved and the choice of a loss function in association with Bayes' theorem. It rests on the notion that a parameter within a failure model is not merely an unknown quantity, but rather behaves as a random variable, which follows some distribution. In the area of life testing, it is indeed realistic to assume that a life parameter is stochastically dynamic.

Research Center for Bayesian Applications, Inc. puts an emphasis on the strategic application of knowledge, approaches and techniques that will serve as foundation for improved implementation in academia and industry.

The purposes for which the corporation is organized are:
