The undersigned incorporator(s), for the purpose of forming a Non-Profit Corporation under Chapter 617 of the Florida Statutes, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I

The name of this corporation shall be: **THE PROVINCE OF CATAMARCA AGENCY PROMOTION, CORP.** (is translate of Agencia de Promocion de la Provincia de Catamarca)

ARTICLE II

This corporation shall commence existence upon the date of filing with the Division of Corporations, State of Florida, and shall have perpetual existence.

ARTICLE III

The principal place of business of this corporation: 16300 NE 19 Ave. Ste. C- North Miami Beach - FL 33162.

ARTICLE IV

The purpose for which the corporation is organized is:

1. To help the Province of Catamarca in its economical, political, and social development; participating without exemption with the Provincial Government, every Municipality that makes part of it, and to the sectors of the society representing its [Province of Catamarca] interest.

2. To establish an office in the United States of America on a strategic location. 


