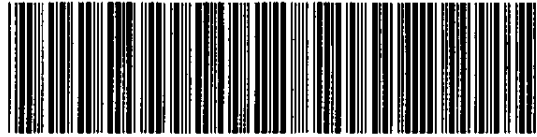

ARTICLE III

PURPOSE
