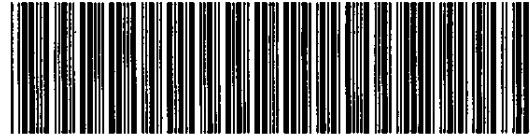

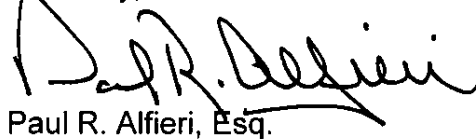

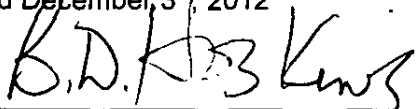

Pursuant to section §617.1402 - §617.1403 of the Florida Statutes, this corporation submits the following articles of dissolution:


1. The name of the corporation is **The Marie Green Forum for Global Missions, Inc.**; and
2. The effective date of dissolution is December 31<sup>st</sup>, 2012; and
3. The corporation has members and the dissolution was approved by the board of directors and members of the corporation on December 3<sup>rd</sup>, 2012. The number of votes cast for dissolution was sufficient for approval; and
4. That all liabilities and obligations of the corporation have been paid or discharged or that adequate provision has been made therefore; and;
5. That all remaining property and assets of the corporation have been distributed in accordance with its articles of incorporation to **OneHope, Inc.** or another 501(c)3 entity; and

**WHEREAS**, On December 3, 2012, at a meeting in which adequate notice was provided and at which a quorum was present, the members and directors of **The Marie Green Forum for Global Missions, Inc.**, a Florida Not-For-Profit corporation, (the "**Corporation**") met for the purpose of approving the dissolution of the Corporation pursuant to F.S.S. 617, Sections §1402 and §1403 and approved the effective date of the dissolution of the Corporation as of December 31<sup>st</sup>, 2012.

**RESOLVED**: That all liabilities and obligations of the Corporation have been paid or discharged or that adequate provision has been made therefore; and

**FURTHER RESOLVED**: That all remaining property and assets of the Corporation shall be distributed to **OneHope, Inc.**, a 501(c)3 entity in accordance with the Corporation's articles of incorporation; and

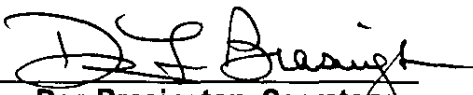

That the dissolution of **The Marie Green Forum for Global Missions, Inc.** pursuant to F.S.S. §617.1402 and §617.1403 is formally approved effective December 31<sup>st</sup>, 2012 and the president of the Corporation is authorized to file the appropriate documents with the state of Florida, Secretary of State, Division of Corporations to effectuate the dissolution.
