ARTICLES OF INCORPORATION

The undersigned, a citizen of the United States, desiring to form a Corporation Not for Profit under the Corporation Not for Profit Law of Florida, Chapter 617, Florida Statutes, certifies and acknowledges:

ARTICLE I. NAME.

The name of the Corporation Not for Profit shall be the Save our Bay, Inc. ("Corporation").

ARTICLE II. DURATION.

The duration of the Corporation shall be perpetual.

ARTICLE III. PRINCIPAL OFFICE.

The principal office and mailing address of the Corporation is 541 Lake Murex Circle, Sanibel, Fl 33957.

ARTICLE IV. PURPOSE.

The Corporation is organized exclusively for domestic charitable, educational and scientific purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, as may be amended, including the following:

- 1. To protect both the human and natural environment including air, water and natural resources and recreational opportunities on San Carlos Bay, Pine Island Sound, and the Caloosahatchee River estuary as well as the beaches, uplands and wetlands of Sanibel Island, Captiva Island and their associated offshore islands, and the Sanibel Causeway connecting the mainland to these areas.
- 2. To formulate, request, publicize and implement repair and rehabilitation of the existing Sanibel Causeway to ensure the bridges and causeway are safe and in good to excellent condition; and to ensure that preventative and corrective maintenance is performed on a routine basis; to maintain the bridge and causeway in a safe condition in perpetuity.
- 3. To use media resources to promote public awareness and education consistent with these purposes.

- 4. To create an information system for evaluating, reporting and distributing data consistent with these purposes.
- 5. To offer assistance to other not for profit corporations in promoting these purposes.
- 6. All other purposes allowed under Florida Statutes Chapter 617 and the 501(c)3 regulations of the Federal Internal Revenue Service.

ARTICLE V. MEMBERS.

The qualifications for members and the manner of their admission shall be as stated in the bylaws of the Corporation.

ARTICLE VL POWERS.

The powers of the Corporation shall be as provided in Chapter 617, Florida Statutes with the following limitations within the meaning of section 501(c)(3) of the Internal Revenue Code, as may be amended:

- A. No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, officers, or other private persons except that the Corporation shall be authorized and empowered to pay expenses for services rendered by members, directors, officers or compensation to other private persons and to make payments and distributions in furtherance of the purposes set forth in Article IV.
- B. No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation and the Corporation shall not participate or intervene in, including the publishing or distributing of statements, any political campaign on behalf of or in opposition to any candidate for public office.
- C. Notwithstanding any other provision of these Articles, this Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this Corporation.
