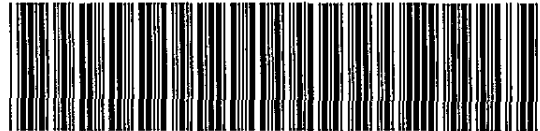

**ARTICLES OF INCORPORATION
OF
TEACHING AVERY RESOURCE FOUNDATION, INC.**

The undersigned hereby establishes the following for the purpose of becoming a Not for Profit Corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida providing for the formation, liability, rights, privileges and immunities of a Corporation for:
TEACHING AVERY RESOURCE FOUNDATION INC.

**ARTICLE I
NAME OF CORPORATION**

The name of this corporation shall be TEACHING AVERY RESOURCE FOUNDATION, INC.

ARTICLE II

The mailing address of the Corporation is P.O. Box 8731, West Palm Beach, FL 33407
Street Address: 555 W. 6th #2, Riviera Beach, Florida 33404

ARTICLE III

This Corporation is organized for the following purposes:

To have and to exercise all the powers now or hereafter conferred by the laws of the State of Florida upon corporations organized pursuant to the laws under which the Corporation is organized and any and all amendatory thereof and supplemental thereto.

For the purpose of transacting any or all lawful business.

To do any and everything pertinent to the above.

To conduct seminars, workshops for family development.

To conduct cultural education, afterschool activities and programs

To provide community and family service workshops in health and education.

Providing resource services to families with children who have disabilities but not exclusively.

Act in any other fashion and engage in other activities and functions that are proper and further the goals and purposes of the corporation.

No part of the activities of the corporation shall be the carrying on or Propaganda or otherwise attempting to influence legislation and the corporation shall not participate in or intervene in (including publishing or distributions of statements) any political campaign on behalf or any candidate for public office.

Notwithstanding any provisions of these articles, the corporation shall not carry any other activities not permitted to be carried by the corporation exempt from federal income tax under section 501c3 of the Internal Revenue Code of 1986 or the corresponding provision of any future United State Internal Revenue Law.

To have and exercise all the powers necessary or convenient to effect the objects for which it is formed, and in general to have an exercise all powers conferred by the State of Florida upon corporation created under Florida's law as they may now be or are hereafter amended. The foregoing enumeration of the objects purposes and powers of the corporation is not intended to and does not prohibit or limit the exercise of any other or further rights or powers which may now or hereafter be allowed or permitted by law to the corporation, provided, however, that all gifts and bequests to the corporation and the net earnings and assets of the corporation shall be used only in the United State of America exclusively for the purpose for which it is formed.

ARTICLE IV BOARD OF DIRECTORS AND MEMBERSHIP

The qualification for members and the manner of their admissions are stated in the bylaws of the Corporation. Annual appointments are conducted selecting a new member and position change for TEACHING AVERY RESOURCE FOUNDATION, INC.
