The undersigned person, acting as incorporator of a corporation not-for-profit under the Florida Not-For-Profit Corporation Act, as set forth in Chapter 617 of the *Florida Statutes*, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I
Name**

The name of the corporation is **FLORIDA MEDICAL ALTERNATIVES & NAPRAPATH ASSOCIATION, INC.**

**ARTICLE II
Principal Office and Mailing Address**

The street address and mailing address of the principal office is **115 E. Granada Boulevard, Suite 4, Ormond Beach, Florida 32174.**

**ARTICLE III
Purpose for which the Corporation is Formed**

This corporation is a not-for-profit corporation. This corporation is organized exclusively for charitable purposes within the meaning of section 501(c)(3) of the Internal Revenue Code. Specifically, this corporation is organized for the purpose of promoting natural health care.

**ARTICLE IV
Dissolution**

Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be distributed to a not-for-profit fund, foundation, or corporation which: a) is organized and operated as an allowable not-for-profit corporation for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law; and b) has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provisions of any subsequent federal tax laws.

**ARTICLE V
Registered Agent and Office**

**ARTICLE VI
Incorporator**
