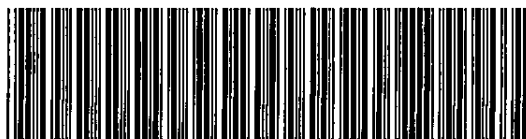

Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida not for profit corporation adopts the following amendment(s) to its Articles of Incorporation:

AMENDMENTS ADOPTED

ARTICLE II - PRINCIPAL OFFICE

(ARTICLE AMENDED)

The initial principal address of this corporation is **8875 Hidden River Parkway, Suite 300, Tampa, Florida 33637.**

ARTICLE III - PURPOSE

(ARTICLE AMENDED)

This not for profit corporation is organized and formed pursuant to Sections 624.4623 and 440 of the Florida Statutes for the purpose of seeking the prevention or lessening of casualty and property losses for its Members and injuries to persons and employees which might result in claims being made against Members. This Corporation is authorized to conduct such services and transact any and all lawful business for such purpose as permitted under the laws of the United States and the State of Florida.

In addition, said organization will operate for the benefit of institutions of higher learning or educational organizations in the State of Florida.

ARTICLE VI - REGISTERED AGENT AND STREET ADDRESS

(ARTICLE AMENDED)

ARTICLE IX - LIMITATIONS

(ARTICLE ADDED)

This not for profit corporation is organized exclusively for charitable, religious, educational, scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

No part of the net earnings of the not for profit corporation shall inure to the benefit of, or be distributable to its members, trustees, offices, or other private persons, except that the not for profit corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an

organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the not for profit corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
