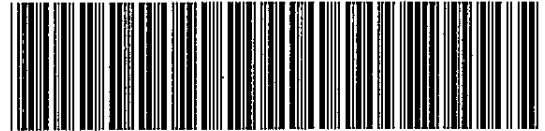

The undersigned, acting as an incorporator of a corporation not for profit pursuant to chapter 617, Florida Statutes, adopt the following articles of incorporation for such corporation.

Article I Name

The name of the Corporation is Faith Fellowship of Tampa Bay, Inc.

Article II Address

The initial principal address of the corporation is 1604 Melodie Drive Brandon, Florida 33510.

Article III Purpose

The Corporation is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The manner and method for carrying out the above purposes is provided in the Articles of Religion and By Laws in the Manual of Faith Fellowship of Tampa Bay, Inc.

Article IV The Board of Directors

The affairs of the Corporation shall be managed by a Board of Directors. The number, manner of election, qualifications for office and duties of these directors are provided in the By Laws of the Manual of said Corporation.

Article IX Membership

The categories of membership, qualifications for membership, and the manner of admission shall be set forth and regulated by the By Laws in the Manual of said Corporation. Members of the Corporation will have such voting rights as are provided in the By Laws in the Manual of said Corporation.

Article X Non-stock Basis

This Corporation is organized under a non-stock basis.

Article XI Distribution of Assets upon Dissolution

Upon dissolution of the Corporation, assets shall be distributed for one or more purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Any such assets not so disposed of shall be disposed of by Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes of to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article XII Officers of Board of Directors

The officers of the Board of Directors shall initially consist of a President, a Vice President of Evangelism, a Vice President of Discipleship, a Secretary, and a Treasurer. The manner of election, tenure of office and filling of vacancies shall be provided for in the By-Laws in the Manual of the Corporation.. The initial officers are as follows.
