The Articles of Incorporation of "THE POWER OF GOD FOUNDATION" INC.

We, the undersigned, being desirous of forming a corporation, not for profit, for charitable purposes, under the provisions of chapter 617, Florida Statute, do hereby propose and subscribe the following Charter.

ARTICLE I NAME

The name of the corporation shall be : THE POWER OF GOD FOUNDATION. INC.

ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be 652 Neumann village Ct Ocoee, Fl 34761

ARTICLE III EXISTENCE

The corporation shall exist perpetually.

ARTICLE IV PURPOSE

The general nature and purpose for which the corporation is organized is charitable.

Article V

The affairs of the corporation are to be managed by the following officers: The President, the vice president, the secretary, who may also be known as clerk, treasurer, and a board of Trustees of not less than three (3) members of the corporation, the number of the Trustees to be fixed by the By-Laws.

ARTICLE VI MANNER OF ELECTION

A majority of vote of all of the members of the corporation who are present and voting shall be necessary to the election of the president, the secretary, the treasurer, the trustees and each of them. No person other than a member of the corporation shall be eligible to hold office in the corporation.

ARTICLE VII THE TRUSTEES

The Trustees shall elect among themselves a chairman and a secretary who shall perform the duties usually pertaining to such office.

ARTICLE VIII INITIAL OFFICERS

The names of the officers who are to manage the affairs of the corporation until the first election or appointment under the Charter and By-Laws shall be:

ARTICLE IX BY-LAWS

The By-Laws and Articles of Incorporation shall be made, altered, amended, or rescinded by a two-thirds (2/3) vote of the members of the corporation present and voting at any regular, annual or special meeting called for that purpose ; the same having been announced for a month prior to the such meeting, further provided that quorum of 25% of the total membership shall be present at such meeting.

ARTICLE X

Notwithstanding any other provisions of these Articles, the purposes for which the corporation is organized are exclusively charitable, literary and educational within the meaning of section 501 © (3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE XI

Amendments to these Articles of Incorporation may be proposed by the Board of Trustees who shall have all the duties and powers usually exercised by the Boards of Trustees. The number of members of such Board shall not be less than three (3) nor more than seven (7). The manner of election or appointment and the terms of office of members of the Board of Trustees shall be determined by the By-Laws.

ARTICLE XII

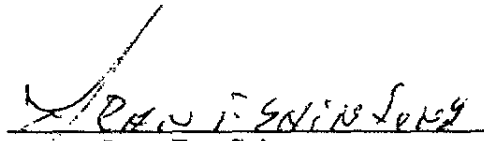
Any member of the Board of Trustees shall be removed in accordance with the removal provisions legislated by the By-Laws.

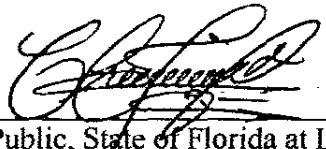
