ARTICLE I NAME

The name of the corporation shall be: Sisters-By-Grace, Inc. - (referred to as Women's Group)

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

Business meetings will be conducted during pre-arranged breakfast meetings at local restaurants in the county.

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

The primary purpose of the Sisters-By-Grace Women's Group is to foster, promote, support, and encourage families, friends and the Lake County community during times of hardship, troubles, and bereavement.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

Nominations:

A nomination committee will be appointed to recommend candidates to fill unexpired terms within thirty (30) days after they occur in the event the vacancy has resulted in fewer than the required minimum number of officers. Candidates shall be elected by a majority vote of the Women's Group at any regularly scheduled meeting. The Nominating Committee shall present a slate of at least one candidate for each expired term of the officers at its last regularly scheduled meeting of the calendar year (if there be any). The Nominating Committee will ensure that the officers is broadly representative of the community. No person shall be denied membership as an officer by reason of race, creed, color, or disability.

Sisters-By-Grace, Inc. (Women's Group)

Election & Term of Office:

Officers shall be elected at the last regularly scheduled women's group meeting of the calendar year. Each year at the last regularly scheduled meeting of the calendar year, officers shall be elected for a term of two (2) years to fill each expired term and to fill the terms of any officers where vacancies have occurred for any reason (i.e. life limiting illness, resignation, expulsion or negligence of an officer).

Elected officers during the even years are President, Vice-President, Secretary, Assistant Secretary, and Treasurer. Officers elected during the odd years are Auditor, Humor Adviser, Parliamentarian, Historian, Chaplain, Chaplain Assistant, and Public Relations Reporter.

Removal of Officers:

In the event an officer and/or member does not act in good faith to the women's group By-Laws or in a manner opposing to the best interest of the sisters, and her conduct is unlawful or deemed disrespectful, her membership will cease by vote of a majority (majority identified as 50% of the officers and 4 members of the membership). Membership will not be reinstated.
