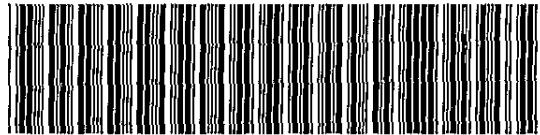

The undersigned, acting as Incorporators, desiring to form a corporation not for profit pursuant to Florida Not for Profit Corporation Act, Chapter 617, Florida Statutes, adopt the following Articles of Incorporation for such corporation:

**ARTICLE I**  
**NAME**

The name of this corporation is FLORIDA PROGRESSIVE ALLIANCE, INC.

**ARTICLE II**  
**ADDRESS OF PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation is 1971 Lee Road, Winter Park, FL 32789.

**ARTICLE III**  
**PURPOSE**

The purpose for which this corporation is organized is to build a grassroots constituency of diverse individuals and organizations in Florida dedicated to nonviolence and to social, economic, and environmental justice; to provide information, coordination, support services, and leadership to individuals and groups dedicated to peace and justice; to put into action the values of liberty, equality, justice, and nonviolence and to encourage elected representatives to incorporate those values into laws and policies of individual states and of the United States; and to raise public awareness of issues of injustice and foster support for remedies to those injustices.

**ARTICLE IV**  
**MANNER OF ELECTION**

The manner in which directors are elected or appointed shall be stated in the bylaws of the corporation.

**INITIAL REGISTERED OFFICE AND AGENT**

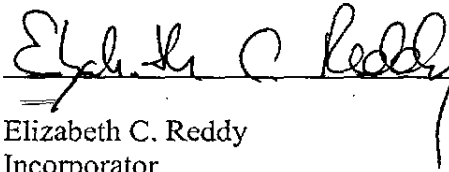

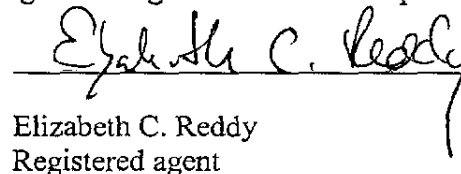
**ARTICLE VII
