**ARTICLES OF INCORPORATION  
OF**

The undersigned incorporator, a resident of the State of Florida and of full age, hereby makes, subscribes, acknowledges and files with the Department of the State of Florida these Articles of Incorporation for the purpose of forming a not-for-profit corporation under the laws of the State of Florida.

**ARTICLE I**

**NAME**

The name of this corporation is **CITIZENS FOR RESOURCES STEWARDSHIP OF BREVARD, INC.**, a Florida not-for-profit corporation (hereafter called the "Corporation" in these Articles).

**ARTICLE II**

**PRINCIPAL OFFICE**

The principal place of business and mailing address of the Corporation is 500 E. Kennedy Boulevard, Suite 200, Tampa, Florida 33602.

**ARTICLE III**

**PURPOSE**
