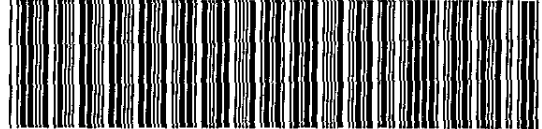

**ARTICLES OF INCORPORATION OF  
RICHARD LUDDEN JOB PLACEMENT SERVICES, INC.**

This is a not for profit corporation formed in compliance with Chapter 617.01 of the Florida Statutes, and with the Internal Revenue Service Code Section 501(c)(3).

**ARTICLE I: NAME**

The name of this corporation is Richard Ludden Job Placement Services, Inc.

**ARTICLE III: PURPOSE**

The general purpose of this corporation shall be to assist individuals who are referred to it by the State of Florida, Department of Education, Division of Rehabilitation to prepare for, to complete the acquisition of, and to assist them in maintaining a successful employment career in appropriate jobs which coincide with the skills possessed by the individuals.

To fulfill this purpose, this corporation will transact the following types of activities:

1. To help these Vocational Rehabilitation individuals in the writing of resumes and in the job-seeking skills needed in interviewing for the potential jobs.
2. To engage in counseling and training endeavors for the individuals which will promote the general well being and the motivation to succeed in the job placement activity.
3. To conduct interviews with these individuals to determine employment needs and to determine the best methods of meeting these needs,
4. To assist in the evaluation of resumes produced by the individuals and to help tailor make these to suit the specific jobs which are sought by the individuals.
5. To provide the opportunity for the applicants to practice completing job application forms so that they might maximize their value for the job-seeking process.
6. To conduct business, have one or more offices, and buy, hold, mortgage, sell, convey, lease or otherwise dispose of real and personal property in the State of Florida for the purpose of promoting the primary purpose of the corporation.
7. To contract debts and borrow money, issue and sell or pledge bonds, notes, and other evidence of indebtedness, and execute such mortgages, transfers or corporate property, or other instruments to secure the payment of corporate indebtedness as the law requires.

8. To comply with the indicated intention of the State of Florida to require Vocational Rehabilitation Independent Contractors who have been performing services with the State of Florida to secure the not-for-profit corporation status.
9. To avoid any political propaganda or activity in the fulfillment of the stated objectives

#### **ARTICLE IV: MANNER OF ELECTION AND INITIAL OFFICERS/DIRECTORS**

The business activities of the corporation are to be managed by the Officers and Directors who are initially appointed by the corporation President. Future officers and directors will be elected by a majority vote of the Officers and Directors in a regularly called meeting of the Corporation. The Officers of Richard Ludden Job Placement Services, Inc. will be President, Vice President, Secretary and Treasurer. Two other Directors will comprise the Team of Directors.
