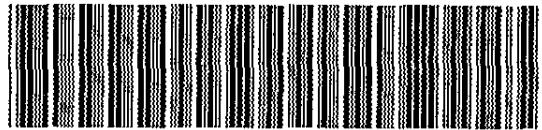

ARTICLE I NAME

ARTICLE III PURPOSE

The purpose(s) for which the corporation is organized is (are): To serve as an extension of the government (local, state and federal). To serve as an extension of the government to make residents aware and provide information and services that are available to the residents of communities by governmental, and private intentions. These services will be provided to very low and low-income individuals and families as described by HUD. Also to develop prototype low-income housing ventures to serve as demonstrations which can be relocate in other areas where the need exists; to promote complimentary and supportive community, economic, and business development for low-income areas.
