

**ARTICLES OF INCORPORATION**  
**OF**

The undersigned, all of whom are citizens of the United States, desiring to form a corporation, pursuant to the Florida Nonprofit Corporation Code.

**ARTICLE I - NAME**

The name of the corporation shall be:

**ARTICLE II - PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

**ARTICLE III - PURPOSE**

The purpose for which the corporation is organized is to



**ARTICLE VI - MEMBERS**

The Corporation shall have no voting members. The management and affairs of the corporation shall be at all times under the direction of a Board of Directors whose operations in governing the corporation shall be defined by the state and by corporation's bylaws.

**ARTICLE VII - DISSOLUTION**

Upon the time of dissolution of the corporation, assets shall be distributed by the board of Directors after paying or making provisions for the payment of all debts, obligations, liabilities, costs and expenses of the corporation for one or more exempt purposes within the mean of 501C(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government or to state and local government, for a public purpose. Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the country in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations as said Court shall determine which are organized and operated exclusively for such purpose.
