ARTICLES OF INCORPORATION OF SAFE BICYCLING COALITION OF PALM BEACH COUNTY. 1

The undersigned incorporator to these articles of incorporation hereby forms a corporation not for profit (the "Corporation") under the laws of the State of Florida as follows:

ARTICLE I Name, Principal Place of Business, and Mailing Address

The name of the Corporation is: Safe Bicycling Coalition of Palm Beach County The principal place of business and mailing address is: c/o Randy Scheid, 221 Wenonah #1, West Palm Beach, FL 33405.

ARTICLE II Term of Existence

The date when corporate existence shall commence shall be the date of the filing of these articles of incorporation by the office of the Florida Department of State and the Corporation shall have perpetual existence thereafter.

ARTICLE III Purpose

The Corporation is organized and shall be operated exclusively for scientific, educational, and charitable purposes, including, for such purposes the following:

To improve the quality of life in Palm Beach County through promotion of safe bicycling and sustainable community transportation systems.

The Corporation shall have all powers now or hereafter granted by law, and in addition thereto shall have all powers lawfully necessary or required to carry out its purposes and objects.
