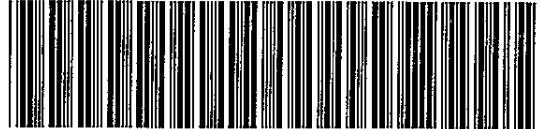

ARTICLES OF INCORPORATION

CHRIST CHURCH OF MARIANNA, FLORIDA

ARTICLE I: The name of this corporation shall be CHRIST CHURCH OF MARIANNA, FLORIDA, Inc.

ARTICLE II: The Church Office shall be:
4439 Marion St.
Marianna, FL 32448

ARTICLE III: PURPOSE. The purpose for which the corporation is organized is:

- (1.) To conduct services of a religious nature; to preach, teach, and instruct in Christianity and the Bible.
- (2.) To win people to Christ.
- (3.) To establish a place (or places) for these activities.
- (4.) To minister to the spiritual, emotional, and physical needs of the community.
- (5.) To establish and maintain such departments and institutions for educating and strengthening in Christianity, as needed.
- (6.) To establish and support Bible Schools, church schools, and other churches as the opportunity arises.
- (7.) To produce literature, tapes, and other media for the instruction of Christians.
- (8.) To solicit funds, collect monies, to receive gifts and bequests, and otherwise raise money to maintain and operate the church for the stated purposes.
- (9.) To expend, contribute, disburse, and otherwise handle and dispose of funds received for the operation of this ministry.
- (10.) To purchase, lease, rent, acquire, own, hold in trust, use, sell, convey, mortgage, or perform real estate transactions as needed for the operation of this ministry.
- (11.) To borrow money, issue bonds, debentures, notes or other obligations for the purposes of this ministry.
- (12.) To govern itself according to these articles and such by-laws as the directors shall establish.

ARTICLE IV: MANNER OF ELECTION. The manner in which the directors
are elected or appointed, *as according to the By Laws*

The directors (board members) shall be the initial three(3).

Other members shall be added by appointment of the chairman.


