Articles of Organization

Preamble:

WHEREAS it is the express purpose of God our Heavenly Father to call out of the world a saved people who shall contribute to the Body of Christ, built and established on the foundation of the apostles and prophets, Jesus Christ being the Chief Cornerstone. WHEREAS the members of the Body of Christ are enjoined to assemble themselves together for worship, fellowship, counsel, and instruction in the Word of God and the work of the ministry and for the exercise of those spiritual gifts and offices provided for in the New Testament, therefore, BE IT RESOLVED that we recognize ourselves as a body of Christian believers working together for the common purpose of spreading the Gospel of our Lord and Savior Jesus Christ, and that under the laws of the State of Florida we may exercise all the rights and privileges granted to religious bodies.

Article I Name:

The name of this corporation shall be Fellowship Prayer Temple Nondenominational, Inc.

Article II Purpose:
