
Enclosed, please find a check in the amount of \$61.25, and a completed application for reinstatement.

Our Secretary, Gail Badger, placed a call to your division on March 10, 2004 to determine why Pineland Park was not listed as being in good standing on the web site. In speaking with one of your representatives, it was determined that the application had been sent back to the prior years Treasurer (2002) Nancy Davis due to lack of Directors names on the application. The treasurer, Nancy Davis, had moved and left no forwarding address, so none of the officers were aware there was a problem with the application.

Ms. Badger discovered the discrepancy, and in good faith placed the call to your office to find out the proper procedure to reinstate the Park in good standing. When she spoke to your staff, Ms. Badger was informed of the possibility of having to pay an additional fee of \$175.00 for reinstatement. However, Ms. Badger was told to write a letter with an explanation of the situation and your office might waive the reinstatement fee.

This letter is to do just that. None of the other officers were aware there was additional information lacking on the application, or that the application had been mailed-back.
