## ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION OF MEASE MANOR RESIDENTS FOUNDATION, INC.

These Articles of Amendment of Articles of Incorporation of Mease Manor Residents Foundation, Inc., a Florida not-for-profit corporation (the "Corporation"), are adopted and filed pursuant to the provisions of Sections 617.1001, 617.1002, and 617.1006, Florida Statutes, as amended.

- 4. In accordance with Article XI of the Articles of Incorporation of the Corporation, the amendment set forth in these Articles of Amendment was duly authorized by the Board of Trustees on April 26, 2021. The vote of the Board of Directors of the Corporation was sufficient for approval.
- 5. The amendment set forth above shall be effective upon the filing of these Articles of Amendment with the Florida Secretary of State.
