Articles of Amendment to Articles of Incorporation of SARASOTA INTERNATIONAL CRICKET CLUB, INC. Document No. N03671

Pusuant to provisions of Section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendments to its Articles of Incorporation.

- 1. Section 3 d) and e) are amended to provide:
 - d) <u>Distribution Preference.</u> In the event of dissolution, liquidation, or winding up of the corporation or the sale of substantially all of its assets, Equity members shall first receive from the proceeds thereof the remaining balance of their capital contributions plus an amount of interest thereon at the rate of 3.50% per annum. Any remaining proceeds and other assets shall be distributed as provided in Section 11 of the Articles of Incorporation, as amended.
 - e) **Redemption.** Equity memberships shall be redeemed by the corporation by payment to each Equity Member annually an amount representing principal and interest at the rate of three and one half percent (3.50%) per annum due pursuant to a ten (10) year amortization schedule. Such annual payments may be deferred by the Board of Directors in years where the corporation does not have sufficient funds to make such payments and meet operating expenses.
- 2. Section 9 of the Articles of Incorpration is amended to provide:

Income and Disributions. A dividend may not be paid, and any part of the income of the corporation may not be distributed to its Patron Members, directors or officers. The corporation may redeem Equity memberships as herein provided and the Board shall provide for the redemption in fixing the annual membership dues. Proceeds from the issuance of Equity memberships shall be used to complete the purchase of real property from Schroeder-Manatee Ranch, Inc. pursuant to that certain Purchase-Sale Agreement dated May 20, 2014, together with an amount representing reasonable interest thereon. In the event of the dissolution of the corporation, the residual assets of the corporation, after redemption of the Equity memberships as herein provided, shall be turned over to one or more organizations described in Section 501(c)(3) and 170 (c)(2) of the Internal revenue Code of 1954, or any corresponding sections of any prior or future Internal Revenue Code, or federal, state, or local government for exclusive public purpose.

The effective date of adoption of the amendments was July \$2014.
