ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF THE COURTYARDS OF SUNTREEF, $\backslash NC$.

Pursuant to the provisions of §617.1006, Fla. Stat., THE COURTYARDS OF SUNTREEE, INC. ("Association") adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: Amendments adopted:

A. The name of the Corporation as currently filed with Florida Department of State is THE COURTYARDS OF SUNTREEE, INC.
