AMENDMENT TO

ARTICLES OF INCORPORATION OF

TALLAHASSEE CYCLING, INC.

ARTICLE III. Corporate Purposes

The Corporation shall be a nonprofit organization formed and organized for the purposes of promoting bicycling for transportation, sport, health, and recreation through education, advocacy, and rider development within the meaning of Section 501(c)(3) of the Internal Revenue Code, and to:

- (1) provide opportunities for group recreational riding both on and off road:
- (2) provide educational and promotional activities to support and generate interest in bicycle riding as a legal, safe and healthy means of transportation;
- (3) educate the general public as to the recreational and health benefits of bicycling;
- (4) assist the public and private school systems in educating children on the safe and effective use of bicycles; and
- (5) promote bicycling as a sport and a healthy lifestyle.

recreation, and fitness within the meaning of Section 501 (c)(7) of the Internal Revenue Code. The purposes of the Corporation will be accomplished by sponsoring activities which allow the members to commingle and provide personal contact and fellowship. These activities include sponsoring bike races, bike rides and other events which support bicycling. No part of the net earnings of the

Corporation shall inure to the benefit of any officer, director, member, or any other person having a personal or private interest in the activities of the Corporation. No substantial part of the activities of the Corporation shall be dedicated to attempting to influence legislation by propaganda or otherwise. The Corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office.
