ARTICLES OF AMENDMENT
TO ARTICLES OF INCORPORATION

SERELARY OF STATE

OF

FRIENDS OF THE CLIFFORD C. SIMS STATE VETERANS NURSING HOME, INC.

Pursuant to the provisions of Section 617.1006, Fla. Stat., FRIENDS OF THE CLIFFORD C. SIMS STATE VETERANS NURSING HOME, INC hereby adopt this Amendment to its Articles of Incorporation for the purposes of changing Article II, paragraph (A), and Article VII of the corporation. Such change shall be reflected as follows:

ARTICLE II

A. The specific and primary purposes for which this corporation is formed is to operate for purposes within the meaning of Section 501(C)(3) of the Internal Revenue Code of 1954 or corresponding section of any future federal tax code, Florida Statutes, Chapter 617 and 196, and Article VII, Section 3 of the Florida Constitution, and to secure and distribute contributions individuals, corporations, governmental entities and foundations to promote charity. or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization if then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for

such purposes.

ARTICLE VII

This corporation is not organized, nor shall it be operated for the pecuniary gain or profit and it does not contemplate the distribution of gains, profits, or dividends to the directors thereof and it is organized solely for non-profit purposes. The property, assets, profits and net income of this corporation are irrevocably dedicated to purposes set forth and permitted under Section 501 (C)(3) of the Internal Revenue Code and no part of the profits or net income of this corporation shall ever inure to the benefit of any private shareholder or individual. Upon the dissolution or winding up of this corporation, the assets remaining after of, or provision for payment of, all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for purposes under section 501 (C) (3) of the Internal Revenue Code and which has established its tax-exempt status under Chapter 617, Florida Statutes.

The remaining Articles shall remain unchanged.

The date of adoption of the amendment was June 15th 4k, 2005. The amendment was adopted by the members and the numbers of votes cast for the amendment was sufficient for approval.
