ARTICLES OF INCORPORATION

OF TEEN COURT OF GULF COUNTY, INC.

The undersigned, acting as Incorporator of a Not for Profit Corporation pursuant to Chapter 617 of the laws of the State of Florida, adopts the following articles of incorporation for such corporation.

ARTICLE I. NAME

The name of the Corporation shall be: Teen Court of Gulf County, Inc.

ARTICLE II. PRINCIPAL OFFICE

The street address of the principal office of the Corporation is:

1000 Cecil Costin Sr. Blvd. Room 126 Port St. Joe, FL 32456

ARTICLE III. DURATION

The period of the duration of this corporation shall be perpetual unless dissolved according to law.

ARTICLE IV. PURPOSE

The corporation is organized exclusively for educational purposes, and more specifically for the operation of a teen court to promote juvenile justice in Gulf County, Florida.

ARTICLE VI. ELECTION OF DIRECTORS

The manner is which directors are elected or appointed in the future shall be stated in the By-Laws.

ARTICLE VII. CORPORATE EARNINGS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in Article IV hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future tax lay, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future tax law.

ARTICLE VIII. REGISTERED OFFICE AND AGENT
