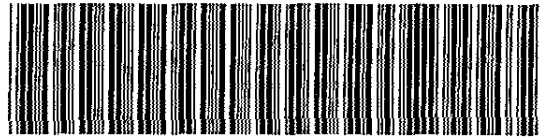

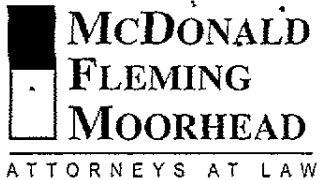

**ARTICLES OF INCORPORATION  
OF  
C & M MINISTRIES, INC.  
A Florida Not For Profit Corporation**

**ARTICLE ONE**

The name of the corporation is C & M Ministries, Inc.

**ARTICLE TWO**

The address of the place of business of the corporation is 3111 Zepp Lane, Pace, Florida, and the mailing address of the corporation is 3111 Zepp Lane, Pace, Florida 32571.

**ARTICLE THREE**

This corporation is organized for charitable, religious and educational purposes including, the establishment and maintenance of a place of religious worship and a place or places of refuge for children and youth; places of transformation in adults; parsonages; housing of servants, schools; an academy; colleges; print shops; day-care centers, and camps; the evangelizing of the unsaved by proclaiming the Gospel of the Lord Jesus Christ; the educating of believers in a manner consistent with the requirements of the Holy Scriptures (King James Bible), on Sunday and the weekdays in schools of Christian education; and the maintaining of missionary activities in the United States and any foreign country, together with such other related not for profit activities as may be approved and set-forth in the bylaws of the corporation from time to time.

**ARTICLE FOUR**

The Board of Directors shall consist of three to seven individuals who shall manage the business and affairs of the Corporation as officers or directors. The directors need not be residents of Florida. Each director shall be elected by majority vote of the existing directors and shall serve for the term of one year or until his or her successor is elected and qualified or until his or her earlier resignation or removal. There shall be no limitation against any officer or director serving successive terms. The incorporators shall be the initial directors of the corporation.

**ARTICLE FIVE**

Any assets remaining after the dissolution of the corporation and the disposition of all debts and obligations shall be donated to a ministry of Independent Baptist Faith or similar faith as approved by the directors which qualifies as a not-for-profit, tax-exempt entity.




