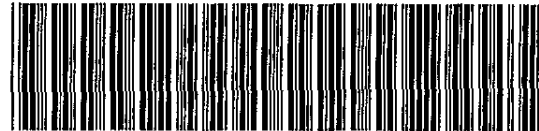



## **SECOND AMENDMENT TO ARTICLES OF INCORPORATION**

### **ARTICLE I:**

**Name:** Laboring In God's House Together Ministry, Inc. (hereinafter referred to as: **L.I.G.H.T. Ministry, Inc.**)

**ARTICLE II:** P. O. Box 608421, Orlando, Florida (County: Orange) 32860-8421

**ARTICLE III:** (Articles have been amended to reflect a more accurate and defined purpose for which this church ministry was formed).

This Church is a faith-based non-profit organization working for the up-building of God's Kingdom. The purpose of the church shall be for the preaching of the gospel and the teaching of the truths from the Holy Bible. This church recognizes the Bible as the inspired and infallible Word of God and that it is the supreme and final authority in all matters of faith and practice. By the Holy Bible, we mean the collection of sixty-six books from Genesis to Revelation which is the Word of God. This church is organized and shall operate for religious, charitable and educational purposes and is open to those members who profess that there is only one true and living God, who is the Maker and Supreme Ruler of heaven and earth, and believe in the Divine unity of the Godhead – three persons: The Father, the Son and the Holy Spirit, equal in every Divine perfection, and profess that Jesus Christ is Lord and Savior of all.

*This church, through outreach ministry will aid in providing provisions for those deemed less fortunate, homeless, sick and shut-in. This church will assist individuals that become members of L.I.G.H.T. Ministry who desire to live their lives for Christ, exhibit a willingness to learn and have a willingness to work for the up building of God's kingdom. This church ministry is also designed to assist women when they are released from jail and/or prison. These individuals must have documented proof of participation in the Jail Ministry while incarcerated and have proven to be ready for rehabilitation in the outside world. We will assist these individuals in the areas of biblical studies, job readiness and job training skills, improving their educational and career planning needs, communication skills, Christian counseling, providing workshops on various topics and to act as a referral source for other needed services in which the member(s) may require. Church services will be provided at L.I.G.H.T. Ministry, and the church may also provide a means of temporary shelter for female individuals that are homeless and seeking a more spirit-filled life.*

The Mission of L.I.G.H.T. Ministry, Incorporated is to provide the truth of the Gospel, spiritual guidance and direction, to teach sound doctrine, aid the members in maintaining a spirit-filled and stable lifestyle, and to provide the member(s) with a loving environment where one can grow spiritually and physically in the name of our Lord and Savior Jesus Christ. Our goal is to provide instruction and give direction through the infallible Word of God, to aid in the spiritual improvement of its members, and the evangelization of all nations as stated in the Holy Scriptures. Our goal is also to provide the guidance needed through educational, social and physical training to better equip them with knowledge, teaching them the needed tools to be more productive and successful in life.

### **ARTICLE IV:**

The method in which the Officers will be appointed is as follows: There are a total of five (5) Officers, which have been initially appointed by the President/Founder/Pastor of L.I.G.H.T. Ministry, Inc. There are two (2) titled positions which are as stated:

Trustee and Treasurer

The positions of the Trustee and Treasurer are voluntary positions (without compensation) and shall be maintained until individual steps down or individual is relieved from said position by Pastor and other Officers. At which time, remaining members may solicit for an additional volunteer(s) or the Pastor may elect to appoint an additional volunteer, not to exceed five (5) members. The President/Founder of L.I.G.H.T. Ministry, Inc. is the Pastor, and said individual will teach sound doctrine in order to promote the up building of the kingdom of God.

The Officers are composed of citizens, who will serve faithfully and are vested with decision-making powers in the matters of the church programs and budget. The President/Founder/Pastor of L.I.G.H.T. Ministry, Inc. shall work in conjunction with the other Officers and make presentations on behalf of the Ministry. The Officers shall provide the necessary documentation and financial information in order to assist the Pastor in facilitating and maintaining the best interest of the church ministry.

The Officers shall meet in regular sessions once each month. These civic-minded individuals will contribute their time and talent to guiding the development of L.I.G.H.T. Ministry, Inc. so that it remains responsive to the spiritual, physical and educational needs of its members.

The President/Founder/Pastor of L.I.G.H.T. Ministry, Inc. will act as Liaison to the Officers in representing, obtaining approvals for L.I.G.H.T. Ministry and making recommendations on issues that pertain to L.I.G.H.T. Ministry. The President/Founder/Pastor of L.I.G.H.T. Ministry, Inc. shall hold the said position (Pastor/President) indefinitely and will operate on behalf of L.I.G.H.T. Ministry in the decision-making processes with the direct aid and support of the Officers. The President/Pastor of L.I.G.H.T. Ministry, Inc. shall operate in the best interest of the church organization and shall make responsible decisions that may ultimately affect L.I.G.H.T. Ministry by way of improvement and/or increase and growth in membership. Any major changes or any additions and/or deletions of programs shall be taken before the Officers for approval before any action can be taken. The President/Founder/Pastor of L.I.G.H.T. Ministry, Inc. shall also hold the power to refuse and expel any member(s) that is knowingly and willfully practicing in any form of witchcraft and/or satanic worship, and/or any member(s) that does not adhere to the church practices and beliefs that have been set forth in the Articles of Incorporation.

Any person in agreement with the aim and purpose of this church and meeting qualifications stated below is entitled to hold office in this church:

- a. All officers and teachers must be in good standing and continue steadfastly in faithful service to the Lord.
- b. All officers and teachers must support the doctrinal position of the church.
- c. Each officer and teacher must act in the best interest of L.I.G.H.T. Ministry as a whole.
- d. Each officer and teacher shall maintain Christian ethics, moral consciousness and compassion while exercising self-control.
- e. Any member not acting in the best interest of this church ministry, or not maintaining Christian morals and ethics, and/or brings reproach upon the church (e.g. alcohol, drugs or gambling, etc.) in any manner shall constitute immediate dismissal from his/her position.
- f. If any officer or teacher finds they can no longer meet these qualifications, it is their duty to report it to the pastor/church and surrender office.
- g. All officers and teachers must give by way of support to this ministry in offering and/or tithes.
- h. No member shall sell, loan, grant or make any promises dealing in or around on any portion of the ministry or its property.

## **ARTICLE V:**

**Names/Address of Officers:** Each of the following officers have been appointed by the President/Founder/Pastor of L.I.G.H.T. Ministry, Inc. and reside in the Orange and Seminole Counties.

**Joyce Smith – 500 Banyon Tree Circle #104, Maitland, Florida 32751**

Ms. Smith is actively volunteering in the surrounding communities and involved in outreach ministry. She is a college graduate and has been an Ordained Pastor since 1993.

**Mr. Francis Ziggler – 820 W. Kennedy Blvd., Apt. B-102, Orlando, Florida 32810**

Mr. Ziggler is an active member within the ministry and he continues to seek out inventive ways to assist those that are less fortunate. Mr. Ziggler is a dedicated and faithful servant of the Lord and is currently seeking his A.A. in Biblical Studies at a Theological Seminary.

**Christine Palmer, - 1460 Lancelot Way, Casselberry, Florida 32707**

Ms. Palmer is a Nursing Technician at a Rehabilitative Facility in Orlando and she resides in Casselberry, Florida. Ms Palmer holds a BA in Christian Counseling, A.A. in Biblical Studies, and she is an active volunteer at Orange County Corrections (female population).

**Shirley B. Brooks – 107 Wymore Road, Eatonville, Florida 32751**

Mrs. Brooks is a college graduate and the School Director of Eatonville Christian Academy. She is an active church member and, an active volunteer in outreach ministry and currently involved with the surrounding communities.

**Celia M. Townsend – 86 Castle Brewer Court, Sanford, Florida 32771**

Mrs. Townsend is an active member within the ministry and committed to serving in the surrounding communities. She is a faithful volunteer in hospitals and Seminole County nursing homes, and she is dedicated to helping the needy and those sick and shut-in.

**Daisy Townsend, Pastor - President/Founder of L.I.G.H.T. Ministry, Inc. – P. O. Box 607513, Orlando, Florida 32860**

Pastor Townsend is an active outreach minister for the homeless, teaches bible study at the Orange County Corrections Facility, and actively volunteering at local nursing homes in Orange and Seminole Counties. Pastor Townsend has a BA in Theology, A.A. in Biblical Studies and a Certificate in Mission/Evangelism. She has also coordinated and supervised two (2) programs in the Orange County School System and served as Christian Advisor at VCC in Winter Park, Florida. She has been active in the community in the capacity as: Junior Achievement Consultant and Educational Specialist.

1. No person(s), including the officers and/or teachers shall be able to use this church ministry for anything other than the purpose it was intended, nor, use the name or change the name that has been set.
2. This church ministry does not accept responsibility for any person(s) or employee acting on their own behalf, without the written permission of the President/Founder/Pastor of this organization and will not be sued or defend such actions.
3. No person, officer, teacher and/or employee shall be able to alter, adopt or use corporation's seal.
4. This church ministry has established the order of appointing the Officers. Please refer to Article IV. The Officers shall not be compensated for holding seat.
5. Regular Church services shall be held on Sundays starting at 11:00 a.m., and regular Bible Studies shall be held on Wednesdays starting at 7:00 p.m. Special services can be held at the discretion of the Pastor of L.I.G.H.T. Ministry.
6. Bylaws shall not be changed, amended or repealed unless President/Founder/Pastor and Officers of L.I.G.H.T. Ministry, Inc. has given written authorization. Amendments, repeals or changes will remain in conjunction with faith-based ministry, state and federal laws, and in the best interest of the church ministry.
7. Officers shall, by appointment, maintain not more than five (5) officers.
8. No contracts shall be taken or any other liabilities, borrow money, issue notes, bonds, secure mortgage or pledge any property, franchises or income on behalf of this organization except by written consent of the President/Founder/Pastor and Officers of L.I.G.H.T. Ministry, Inc.
9. No person (s) shall be able to use, deal, hold, own, improve, take, purchase, receive, lease, take by gift, devise, bequest, acquire, deal in or with real or personal property, or any interest therein without written consent from the President/Founder/Pastor of L.I.G.H.T. Ministry, Inc. and its Officers.
10. No person (s) can or will acquire, utilize, dispose of patents, copyrights and trademarks and any licenses and other rights or interests hereunder or therein unless given written authorization by President/Founder/Pastor of L.I.G.H.T. Ministry, Inc. and its Officers.
11. No person (s) shall be able to sell, convey, mortgage, pledge, lease, exchange, transfer, or otherwise dispose of all or any part of its property and assets without written consent from the President/Founder/Pastor of L.I.G.H.T. Ministry, Inc. and its Officers.
12. Only the President/Founder/Pastor of L.I.G.H.T. Ministry, along with advisement and/or recommendations from the Church Officers may employ, hire or terminate positions for said church ministry.
13. No funds shall be withheld, invested or loan out, and no property real or personal shall be held for repayment of loans or invested.
14. Donations from the public, other religious organizations, charitable, and educational (via monies, equipment, furniture, property, clothing, shoes, etc.) may be accepted by President/Founder/Pastor of L.I.G.H.T. Ministry, Inc. and its Officers. Receipts shall be given for any and all donations presented to this church ministry.
15. President/Founder/Pastor of L.I.G.H.T. Ministry, Inc. and its Officers may exercise all powers necessary or convenient to achieve any or all of the purposes for which this church was organized.
