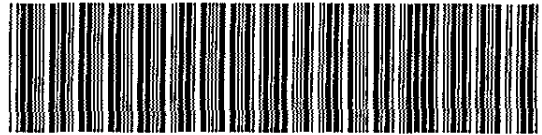

**\*\* Notwithstanding any other provisions of these articles the corporation shall not carry on any other activity not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501(c) (3) of the Internal Revenue Code or (2) by a corporation contribution to which are deductible under Section 170 (c) (2) of the Internal Revenue Code.**

**ARTICLE IV – DURATION**


The duration of this corporation shall be perpetual; it shall have no stock.

**ARTICLE V – MANNER OF ELECTION**


The manner in which the directors are elected or appointed:






**ARTICLE X – CORPORATION DISSOLUTION**


