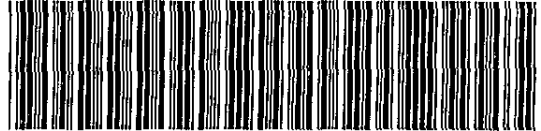

Article 1. Name. The name of the Corporation is On The Path Ministries, Incorporated.

Article 2. Duration: The duration of the Corporation is perpetual

Article 3. Purpose: The purpose of the corporation is as follows:

A. This corporation is a not-for-profit charitable corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are 1). **To promote joy, love, and peace throughout world** 2). **To provide a forum for people promoting joy, love and peace to meet, share and support the global community** 3). **Provide training for individuals and groups to further the development of spreading joy, love and peace throughout the universe** 4). **To become a 501© 3 status organization by the IRS.**

B. To exercise all rights and powers conferred by the laws of the State of Florida upon a nonprofit corporation.

C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

Article 4. Members: The Corporation shall have non-voting members only.

Article 5. Initial Registered Agent and Office. The initial registered agent is. Linda McLeod-Alexis and is initial registered office is 8515 Iris Avenue Largo, Florida, 33777

Article 6. Initial Board of Directors. The initial Board of Directors shall have Seven (7) members. The five members of the board of Directors whose names and addresses are listed below are currently identified. The remaining 2 have not been elected.

The Bylaws shall prescribe the duties and powers of each officer.

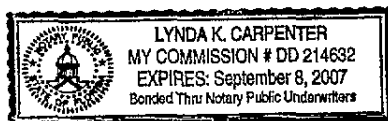
