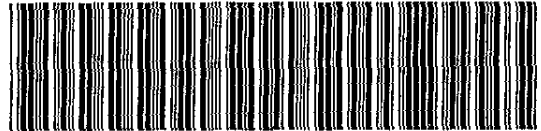

ARTICLES OF INCORPORATION - NON PROFIT
FOR
NAZARENE CHURCH OF PHILADELPHIA, INC.

We, the undersigned hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida, Florida Statutes 617, applicable to corporations not for profit.

ARTICLE I

The name of the corporation shall be Nazarene Church of Philadelphia, Inc., with principal office and mailing address at 820 Soltman Road, Ft. Pierce, Florida 34950.

ARTICLE II

The general purpose of this corporation shall be to provide a setting for worship of Jesus Christ according to the historic traditions and practices of the Nazarene Church of Philadelphia, Inc., and to provide a family atmosphere for the nurture development of the love of Jesus Christ and the desire to serve Him. This corporation may conduct business at one or more locations.

ARTICLE III

Qualification of members and their manner of admission shall be: Any person with an abiding love of Jesus Christ and who desires to worship Jesus Christ in the Nazarene tradition, and further desires a family oriented secure convenient location to exercise their faith may become a member. The corporation shall function utilizing the voluntary contributions from the members contributed during normally scheduled religious services or at any other time as may be convenient or appropriate.

ARTICLE IV

The corporation is to have perpetual existence.

ARTICLE V

Amendments to the Articles of Incorporation may be proposed by any member of the corporation/church and adopted by two-thirds (2/3) vote of the membership present at the annual meeting or at any special meeting called to amend the Articles of Incorporation.

ARTICLE X

By-Laws of this corporation/church may be made, altered or rescinded at any annual meeting or at any specially called meeting with the two-thirds (2/3) vote of the membership present.

ARTICLE XI

The registered office of this corporation/church shall be 1207 Texas Court, Ft. Pierce, Florida 34950, and the registered agent at that same address shall be Joseph Lorius Dessources.
