# AMENDED AND RESTATED ARTICLES OF INCORPORATION

DR. CARTER G. WOODSON AFRICAN AMERICAN MUSEUM, INC.

Pursuant to provisions of Section 617.1006, Florida Statutes, this Florida Not for Profit Corporation adopts the following amendments to its Articles of Incorporation, and the undersigned Chair and Secretary of the DR. CARTER G. WOODSON AFRICAN AMERICAN MUSEUM, INC. hereby certify that the following Amendments to the Articles of Incorporation were approved and adopted unanimously by all of the Members on March 13, 2018, at a meeting duly held after written notice duly given, and by unanimous vote of the Board of Directors at the same meeting, and the number of votes cast for the amendments was sufficient for approval, and these amendments are effective as of April 12, 2018.

### ARTICLE 1

#### <u>Name</u>

The name of the Corporation shall be: DR. CARTER G. WOODSON AFRICAN AMERICAN MUSEUM, INC.

# ARTICLE II

**Duration** 

The Corporation shall have perpetual existence.

#### ARTICLE III

#### Purpose

- (A) This Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organization that qualify as exempt organizations under 501(c) (3) of the Internal Revenue Code of 1986 (and the corresponding provision of any future United States Internal Revenue Law (the "Code").
- (B) Specific Purpose. The specific purpose of this corporation is to maintain a public museum of African American history, art and culture. While acting as a depository for artifacts, objects, and ephemera, the corporation will also present and interpret, through exhibitions and educational activities, the history of people of color locally, regionally, nationally and internationally. The "Dr. Carter G. Woodson African American Museum" will further make the property available as an educational center to preserve, present and interpret African American history, art and culture.

## **ARTICLE IV**

#### REGISTERED OFFICE AND AGENT

The registered office of the corporation in the State of Florida is located at 2240 Ninth Avenue South, St. Petersburg, Florida 33712. The registered agent of the corporation in the State of Florida at the registered office is Terri Lipsey Scott.

# ARTICLE V MEMBERS

(A) The Corporation shall include no less than 3 (three) members. The number of Members can be increased or decreased. The admission of Members to fill vacancies in case of death, resignation, removal or incapacity shall be as provided by Bylaws. The present Members of the Corporation are:

The Bylaws of the Corporation are to be made and adopted by, and may be altered, amended or rescinded by the Members.

# ARTICLE VIII AMENDMENTS TO ARTICLES

These Articles of Incorporation may be repealed, modified or amended, in whole or in part, and new additions made thereto or new Articles adopted by eighty (80) percent of the Members.

# ARTICLE IX INDEMNIFICATION

The Corporation shall indemnify its Members, Directors, Officers, employees, and agents in accordance with provisions in the Bylaws of the Corporation.

The Dr. Carter G. Woodson African American Museum, Inc. has caused these Amended and Restated Articles of Incorporation to be executed on this 12<sup>st</sup> day of April 2018.
