ARTICLE I

The name of this Corporation shall be:

ARLINGTON CONCORD NEIGHBORHOOD ASSOCIATION, INC.

a non-profit corporation with its place of business located at 742 W. AMELIA ST., ORLANDO, FL 32805, having a mailing address of P.O. Box 540059, Orlando, FL 32854-0059.

ARTICLE II

The general nature, purposes, and objectives for which this Corporation is formed shall be:

- (a) the enhancement and improvement of the quality of life for the neighborhood, its residents and real property owners,
- (b) to promote the education, health and well being of the children residing in the neighborhood, and
- (c) to empower and increase access to local, state and federal decision makers affecting the neighborhood, its residents and real property owners.


