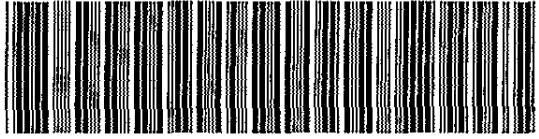



ARTICLES OF INCORPORATION
of
SEASON OF HOPE, INC.

I, the undersigned, hereby file these Articles of Incorporation for the purpose of becoming a corporation under and pursuant to the laws of the State of Florida, Statutes Section 617.0202, providing for the formation, liability, rights, privileges and immunities of a corporation Not for Profit, and for that purpose, I hereby certify, declare and set forth as follows, to wit:

Article I - Corporate Name

The name of the Corporation shall be :

SEASON OF HOPE, INC.,

Article II - Location

The Corporate Location and mailing address are :

Article III - Existence

The purpose for the corporation's existence is to minister, preach, promote and advance the Gospel of Jesus Christ in accordance with the Statement of Faith, (Mark 16:15-18):

"Preach the Gospel of the Lord to all creations ;..... they will place their hands on sick people and they will get well." In Florida, Finland, and throughout the world.

To Minister to the needy and the oppressed, and to offer them food and shelter . To help relocate orphans, old people and invalids from the former Soviet Union to "Israel", the promised land.

Article IV - Officers and Directors

The Corporation, at all times, shall have at least (1) one director to be elected by active members of the corporation.

The initial directors shall be elected by the incorporators.

Article V - Corporate Powers

The corporate powers, though not limited, shall be subject to those authorized under section 617.0302, Florida Statute.

The corporation shall conduct any business activities authorized under Florida Law.

Article IX - Other Guidelines

- 1 - The membership of this Assembly shall consist of those born again christian believers who have been baptised in water, and accepted as members of the Assembly. Membership in the Assembly shall not be dependent upon the payment of membership dues.

- 2 - The membership can be terminated by the Board of Directors when the member fails to obey the Bible doctrine which the Assembly teaches.
- 3 - There shall be one class of membership in the Assembly, and each member shall have the right to one (1) vote.
- 4 - The Assembly reserves the power to amend, alter, change or repeal any provisions contained in the Articles of incorporation in the manner now or hereafter prescribed by statute.
- 5 - The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Trustees.

IN WITNESS WHEREOF, the undersigned, being the original incorporator to the Articles of Incorporation herein, for the purpose of forming a Not for Profit corporation to Preach the Gospel and to offer Safe Harbor to the needy, both within and without the State of Florida under the laws of Florida, do make and file these Articles, thereby declaring that the facts herein are true, this December 31, 2003.

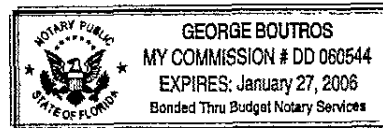
