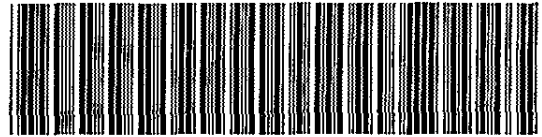

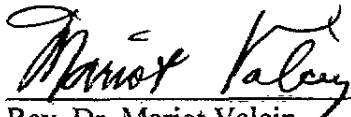

The undersigned, acting as Incorporators of a Florida corporation under the Florida Non Profit Act, Chapter 617. 0202, adopt the following Articles of Incorporation:

Article I: The name of the corporation is:

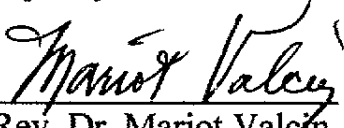

Article IX: Upon dissolution of the Corporation, the Board of Directors shall, after paying or making provisions for the payment of all liabilities of the Corporation, dispose of all of the assets of the Corporation exclusively for charitable, educational, religious, or scientific purposes, and shall at that time qualify as an exempt organization or organizations under section 501 (c) 3 of the Internal revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law). The Board of Directors shall determine that assets not disposed of shall be disposed of by the Circuit Court of the County in which the principal office of the Corporation is then located, exclusively for such purpose or purposes or to such organization or organizations as said Court shall determine are the organized and operated exclusively for the purposes aforementioned.

Article X: The qualifications for membership in the Corporation and the Board of Directors are stated in the By-Laws.
