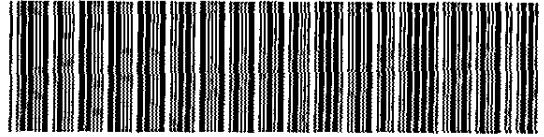



We, the undersigned natural persons of the age of twenty-one years or more, acting as incorporators of a Non-Profit Corporation pursuant to Chapter 617.0202, Florida Statutes (F. S.) adopt the following Articles of Incorporation.

- ARTICLE I: The name of the corporation is Manna Community Development Corporation of South Florida, Inc.
- ARTICLE II: The address of the corporation is 1010 Seminole Drive #902, Ft. Lauderdale, Florida, 33304.
- ARTICLE III: The purpose for which the corporation is organized is to grow children, strengthen families, and build communities. The mission is to build the old waste places in South Florida and raise up the foundations of many generations and be called the repairer of the breach, the restorer of paths to dwell in. (Is.58:12)
- i. Develop an institutional educational facility for middle to low income children in South Florida that systematically prepares them for post secondary education.
  - ii. Create community habitat center that supports and offers training for families through family and job counseling.
  - iii. To collaborate with stakeholders to rebuild neighborhoods, and foster sustainable communities in South Florida by creating quality affordable housing for lower income families, by offering support and training to families to both before and after they purchase their homes, and by engaging in community and economic development.
  - iv. Manna Community Development Corporation of South Florida, shall have the right to engage in and conduct educational, benevolent, and charitable work; to establish and operate schools, homes for the indigent or aged; to publish and sell or otherwise distribute tracts, periodicals and other literature, and conduct a general printing, publishing, and broadcast business in conjunction therewith, all in accordance with its by-laws or any regulation which may be hereafter modified or amended. Should Manna CDC dissolve, after meeting all financial obligations the balance of funds shall be given to like non-profit religious church.
- ARTICLE IV: The manner in which the directors are elected or appointed and administration of all business matter of the corporation shall be vested in the Pastor and the Board of Trustees. The office of president will be filled on a permanent basis by the senior pastor. The senior pastor shall have general oversight and supervision of the church and all of its departments, conduct its services and preside at all business sessions of the church and corporation.
