The undersigned Incorporator, for the purpose of forming a Not for Profit Corporation under Chapter 617 of the Florida Statutes, hereby adopts the following Articles of Incorporation.

**ARTICLE I**

The name of the corporation shall be:

**ARTICLE II**

The principal place of business and the mailing address of this corporation shall be 5520 SW 163 Avenue, Southwest Ranches, Florida 33331.

**ARTICLE III**

The purposes for which the corporation is formed, and the business and the objects to be carried on and promoted by it, are as follows:

1. To promote the preservation of the rural character and lifestyle of the Southwest Ranches in Broward County, Florida.
2. To encourage the acquisition, development and operation, in a cost-effective manner, of parks and open space which compliment the rural character of the Southwest Ranches.
3. To educate the residents of the Southwest Ranches on matters which impact their lifestyle and which threaten to destroy the character of the area.
4. To serve as a clearing-house for sharing knowledge and information concerning the residents of the Southwest Ranches.
