**ARTICLES OF AMENDMENT
to
ARTICLES OF INCORPORATION
of
BOOSTERS OF BOY SCOUT TROOP 100, INC.**

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida Non-Profit Corporation adopts the following amendment(s) to its Articles of Incorporation:

NEW CORPORATE NAME:

BOOSTERS OF CUB SCOUT PACK 100, INC.

AMENDMENTS ADOPTED:

1. Article one (1) of the Articles of Incorporation of the Corporation is hereby amended to change the name of the corporation to BOOSTERS OF CUB SCOUT PACK 100, INC.
2. Article two (2) of the Articles of Incorporation of the Corporation is hereby amended to read as follows:

**ARTICLE II
NATURE OF BUSINESS**

The purpose for which this corporation is formed are exclusively religious, charitable, scientific, literary, or educational within the meaning of the Section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law. In carrying out such a purpose, this corporation shall have all of the powers and authorities granted by statute and law, including the power and authority to accept gifts, devices and other contributions for charitable purposes, to hold and administer the funds and properties received and to expend, contribute and otherwise dispose of funds in the operation of Cub Scout Pack 100, a chartered member of Boy Scouts of America, which is so chartered by the Congress of the United States of America.

The mission of Boosters of Cub Scout Pack 100, Inc., is to provide a permanent structure for the preservation and operation of Cub Scout Pack 100 of Davie, Florida. The corporation will be responsible for holding and management of properties donated to or acquired by Cub Scout Pack 100.

3. The foregoing amendment was adopted by the Board of Directors on the 22nd day of January, 2004. There no members or members entitled to vote.


